Gray; Deputy Administrator, Natalie Corman; and Executive Secretary, Natalie Bird.

### IV. MEETING MINUTES

Commissioner Higgins made a motion to approve the Minutes from the Board of Commissioners' meeting held Tuesday, February 7, 2017. The motion was seconded by Commissioner Dershem and unanimously approved.

### V. ACTION ITEM(S)

- B. Commissioner Higgins said the check of the week was to West Penn Power in the amount of \$38,389.95 and made a motion to approve the check run in the amount of \$677,257.24 dated February 10, 2017. The motion was seconded by Commissioner Dershem and unanimously approved.
- VI. DEPARTMENT HEADS DIRECTORS GUESTS Commissioner Higgins made a motion to add the following (A-E) to the Consent Agenda for Tuesday, February 21, 2017.
  - A. Adult Services Faith Ryan requested the Board of Commissioners approve a contract with Centre County Youth Service Bureau to assist the administration of the Rental and Mortgage Assistance Program (RAP) funds for rental and security deposit assistance. Centre County Youth Services Bureau will distribute funds to landlords per check requests submitted by the Office of Adult Services. The total allocation that can be expended on administration cost is \$4,000. The contract total is \$41,207.40 with the source of funding as follows: State \$41,207.40 for the period March 1, 2017 to June 30, 2017. Adult Services received a termination notice from Interfaith Human Serviced effective February 3, 2017 to March 3, 2017 Dept. 501.
  - B. <u>Children and Youth Services</u> Julia Sprinkle present the following contracts and contract renewals to the Board and requested their approval.
    - i. Approve a contract between the County and Common Sense Adoption Services, Inc. to provide foster care services for dependent/delinquent youth. The contract total is \$20,300 with the source of funding as follows: State \$16,240.00; County Match \$4,060.00 for the period July 1, 2016 to June 30, 2017 Dept. 511.

- ii. Contract Renewal between the County and Kristie Kaufmann of Mt. Nittany Medical Center Health Services to provide administrative consultation as needed. The contract total is \$1,500.00 with the source of funding as follows: State \$1,200.00; County Match \$300.00 for the period of January 1, 2017 to December 31, 2017 Dept. 511.
- iii. Contract Renewal between the County and Premier Biotech to provide drug testing products and laboratory services. The contract total is \$6,500 with the source funding as follows: State \$5,200; County Match \$1,300 for the period January 1, 2017 to December 31, 2017 Dept. 511.
- iv. Contract Renewal between the County and Bethesda Children's Home to provide residential shelter/care for dependent/delinquent youth. The contract total is \$4,500 with the source funding as follows: State \$3,600; County Match \$900.00 for the period July 1, 2016 to June 30, 2017 Dept. 511.
- C. Emergency Communications 911 Dale Neff requested that the Board of Commissioners approve an agreement between Mission Critical Partners and Centre County 9-1-1 for Mission Critical Partners to provide the ALI Database Support and Maintenance to maintain 9-1-1 phone database and addressing. The contract total cost is \$16,500 to be billed at \$1,500 monthly for the period February 1, 2017 December 31, 2017. The interim contract expired on February 1, 2017 and the funds for the new contract are budgeted Dept. 354.
- D. <u>Maintenance</u> Lee Sheaffer requested that the Board of Commissioners approve an agreement between the County and Brian Lutz Painting to have the office of Register of Wills painted. The contract total cost is \$4,950.00 for the period of February 6, 2017 to July 31, 2017 Dept. 161.
- E. <u>Planning</u> Memorandum of Understanding for the Final Land Development Plan for the Philipsburg-Osceola Senior High Athletic Facility Improvements; CCPCDO File No. 16-17. This proposal constitutes a Final Plan submission showing a 1,800-2,000 seat bleachers, team room building, concession stand, restroom facility, sidewalk system as well as corresponding infrastructure to service the proposed land development activity; located on lands of the Philipsburg-Osceola Senior High School, off of School Street, Philipsburg Borough Dept. 151.

The motion was seconded by Commissioner Dershem and unanimously approved.

- C. <u>Sheriff</u> Approve the taser cartridge replacement plan with Taser, Inc. The plan is to include batteries and locks the replacement price for five years. The contract total is 9,101.81 for the period February 2017 February 2021 Dept. 211.
- D. <u>Transportation</u> Pennsylvania State University In-Kind purchase of a 2013 Dodge Durango with 78,208 miles to replace a vehicle in Mapping and Tax Assessment Office. The total cost is \$19,580.00 all inclusive – Dept. 532.
