

BOARD OF COMMISSIONERS' MINUTES

I. CALL TO ORDER

The public meeting of the Centre County Board of Commissioners was convened at 10: AM by Chair of the Board Michael Pipe.

II. PLEDGE OF ALLEGIANCE

In attendance were Commissioner Michael Pipe, Commissioner Mark Higgins, Commissioner Steven Dershem, and Administrator Margaret Gray.

County personnel present included Bob Sweitzer, Bryan Sampsel, Kristen Simkins and Controller Jason Moser.

Representatives from the news media included Gary Sinderson and Evan Hinkley.

IV. MEETING MINUTES

Minutes from the Thursday, March 26 and Tuesday, March 31, 2020 Board of Commissioners' meeting.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to approve the minutes from the March 26 and March 31, 2020 Board of Commissioners' meetings.

V. PROCLAMATION

A. <u>Proclamation 5 of 2020</u> – Commissioner Pipe noted that due to the current COVID-19 pandemic, there is a decrease in the number of mandated reporters that have daily contact with children due to closure of day cares and schools. The safety of children depends on both mandated and non-mandated reporters. Centre County has a wide array of educational and preventative programs throughout the community that are effective in preventing the abuse of children.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to adopt Proclamation 5 of 2020 proclaiming April as Child Abuse Prevention and Awareness Month.

C. Proclamation 6 of 2020 – Conservation District Director Bob Sweitzer joined the Board to proclaim April 22, 2020 as Environmental Education Day. Commissioner Pipe congratulated Bob on his upcoming retirement and thanked him his many years of service to Centre County Government. Commissioner Dershem has worked with Bob for a number of years on the Conservation District Board of Directors. He said Bob has made an impact on many people locally and at the State and National level.

Bob said Envirothon has been near and dear to his heart. Celebrating Earth Day is a great way to recognize the importance of protecting our natural resources. The County Envirothon is open to all students in any of the Centre County schools. An environmental education program that started in Pennsylvania in 1979 has now spread all over the United States, Canada and China. The Conservation District also sponsors an annual poster contest open to elementary through junior high students. Commissioner Pipe added that the Conservation District touches the lives of a lot of people in the County.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to adopt Proclamation 6 of 2020 proclaiming April 22 as Environmental Education Day.

Commissioner Dershem announced that Jim Coslo will succeed Bob Sweitzer as the Director of the Conservation District.

VI. COVID-19 PLANNING AND RESPONSE

A. Families First Coronavirus Response Act

Administrator Margaret Gray introduced revisions to the COVID-19 Employee Leave Directive in response to the Families First Coronavirus Response Act. Director of Human Resources explained that the Act allows for changes to the Family Medical Leave Act (FMLA), including emergency leave allowing a shorter time frame for employees to have been employed to be eligible for FMLA as well as the ability to take the leave to care for children due to schools or daycare closure. The County has already been providing employees with leave as required by the Act. Changes to the directive are being made to be in compliance with the Families First Coronavirus Response Act.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to approve the amendment the COVID-19 Employee Leave Directive

B. Resolution 9 of 2020 - A Resolution of the County of Centre, Commonwealth of Pennsylvania, amending and supplementing the Centre County Tax Collection Policy. Margaret introduced the Resolution that will allow for the adjustment to the payment schedule for real estate taxes in Centre County. Face value payment period, without a discount, will be extended from May 1 through June 30 to May 1 through September 20. Margaret explained that each municipality has the option to adjust this payment schedule individually. The municipality may take similar action however, are not required to. A draft resolution was prepared by the County Solicitor and provided to each municipality - Dept. 111.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to adopt Resolution 9 of 2020.

C. Amendment to the Public Meeting Rules adopted on March 17, 2020.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to table the amended Public Meeting Rules.

VII. REQUEST FOR PROPOSALS

<u>Planning</u> – Administrator Margaret Gray provided an overview of the Mountaintop Activity Center project in Clarence. This is the final project of five that were awarded under the \$100,000 DCED Keystone Communities Grant received with assistance from former State Representative Mike Hannah. Two proposers submitted responses for the RFP - Mountain Top Activity Center building renovations project. All required documents were received – Dept. 151.

On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to add item C.

A. <u>Planning</u> - Proposal from Herbert, Rowland & Grubic (HRG) to perform professional services as Coordinator for the Phase III Chesapeake Bay Watershed Implementation Plan. The contract total is \$95,000 for year one, which is State funded for the period of April 15, 2020 through December 31, 2020 – Dept. 151.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to add the Proposal from HRG to next week's Consent Agenda.

B. Human Services

 Adult Services – Grant agreement with the US Department of Housing and Urban Development (HUD) for the Fiscal Year 2019 competition to continue funding the Centre County Rapid Re-Housing Program. The project total is \$213,208 for the period of October 1, 2020 through September 30, 2021 – Dept. 501.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to add the grant agreement with HUD to next week's Consent Agenda.

iii. <u>Drug and Alcohol</u> – Additional funding through the Pennsylvania Department of Drug and Alcohol Program (DDAP) for training and services. Federal funding in the amount of \$93,900 will provide State mandated training for County staff and providers with additional Vivitrol funding available for community and correctional individuals. Program total is \$1,312,945, which is funded as follows: Federal \$863,598, State \$435,175, and County \$14,172 for the period of July 1, 2019 through June 30, 2020 – Dept. 562.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to approve additional funding from DDAP

C. <u>Elections</u> – Purchase of the Omation 306S Letter Opener from Pitney Bowes in the amount of \$17,265.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to approve the purchase from Pitney Bowes.
