## **CENTRE COUNTY LOW FEE ATTORNEY REFERRAL PROGRAM JUNE 2017**

The Low Fee Attorney Referral Program is comprised of four lists (Criminal, Civil, Family, and Wills/ Estates/ Guardianships) that are made available to potential clients who have indicated a need for low fee representation. Some attorneys have also provided specific practice areas. You will need to contact the attorneys listed to determine whether they handle your legal issue. The Criminal List also includes whether an attorney handles criminal matters at the District Justice and Juvenile level. The attorneys are listed alphabetically.

The attorneys who are on this list have agreed to offer an initial one-half hour (30 minute) consultation for no more \$25.00. In some instances, the consultation may be free. Thereafter, the fees charged by the attorney will be at the discretion of the attorney and the client and will be memorialized in a formal fee agreement that both attorney and client will sign. Some practice areas have specific guidelines regarding how fees are determined or said fees may need to be approved by the court. Please keep in mind that an initial consultation does not establish an attorney/client relationship. This is ultimately determined by you and the attorney.

The Centre County Bar Association is the administrator of this program and the administration of this program does not create an attorney/client relationship with anyone who uses the information provided as part of the Low Fee Attorney Referral Program.
