The Low Fee Attorney Referral Program is comprised of four lists (Criminal, Civil, Family, and Wills/ Estates/ Guardianships) that are made available to potential clients who have indicated a need for low fee representation. Each of these lists is sub-divided into specific practice areas. You will need to contact the attorneys listed to determine whether they handle the type of legal issue that you have. The Criminal List also includes whether an attorney handles criminal matters at the District Justice and Juvenile level. The remaining lists include the specific practice areas for each attorney on the list. The attorneys are listed alphabetically.

The attorneys who are on this list have agreed to offer an initial one-half hour (30 minute) consultation for no more \$25.00. Thereafter, the fees charged by the attorney will be at the discretion of the attorney and the client and will be memorialized in a formal fee agreement that both attorney and client will sign. Please keep in mind that an initial consultation does not automatically establish an attorney/client relationship. This is ultimately determined by you and the attorney.

The Centre County Bar Association is involved solely as the administrator of this program and the administration of this program is not intended to create an attorney/client relationship with anyone who uses the information provided as part of the Low Fee Attorney Referral Program.
