 Adult Services - On a motion by Commissioner Higgins, seconded by Controller Moser, the Board voted unanimously to approve the expansion of funding streams for two (2) temporary positions, full-time Caseworker 1-Adult Services, Adult Services, (p.c. #06 & 07, non-exempt), to include Human Services Block Grant and Emergency Rental Assistance Program funding -Dept. 501.

Human Services Administrator Natalie Corman reported that at the March 11 and March 25 Board of Commissioners meetings the Board approved the creation and hiring for these two temporary positions using Emergency Rental Assistance Program (ERAP) funding. The State has indicated the ERAP funding will be extended into 2022.

Commissioner Pipe asked how these additional positions have affected the funding and administrative workload for Service Access Management (SAM). Natalie stated that currently this has not affected the funding or workload for SAM.

ii. <u>Transportation</u> - On a motion by Controller Moser, seconded by Commissioner Higgins, the Board voted unanimously to approve the voluntary demotion/change in title/department for Susan Watson from full-time Magisterial District Court Secretary, MDJ-Gillette-Walker, (p.c. #10, non-exempt), at SG-N08C(03)--\$14.09/hour to full-time Vehicle Operator, Transportation, (p.c. #14, non- exempt, replacing V.
