A. Polling Locations

i. Change of Polling Location for the May 18, 2021 Municipal Primary

1. Precinct 18 State College Northwest from the Weston Center to Alpha Fire Company, 400 West Beaver, State College
2. Precinct 41 College North from C3 Sports to Centre Region Active Adult Center, located in the Nittany Mall.

Jodi Nedd stated the change in location for Precinct 41 is permanent, while the change in location for Precinct 18 is temporary.

Action: *On a motion by Commissioner Pipe, seconded by Commissioner Dershem, the Board voted unanimously to approve the temporary change in polling location for Precinct 18 and the permanent change in polling location for Precinct 41.*

Last day to apply for a mail-in or civilian absentee ballot.

Tuesday, May 18, 2021

MUNICIPAL PRIMARY

Last day for County Board of Elections to receive voted mail-in and civilian absentee ballots (must be received by 8:00 PM).

Tuesday, May 19, 2021

First day to REGISTER after Primary.

Tuesday, May 25, 2021

Last day for County Board of Elections to receive voted military and overseas absentee ballots (submitted for delivery no later than 11:59 P.M. on May 17)
