### I. CALL TO ORDER

The public meeting of the Board of Commissioners was convened at 10:00 AM by Chair of the Board Michael Pipe.

### VI. CONTRACTS/AUTHORIZATIONS

#### A. Human Services

i. <u>Adult Services</u> – Director Faith Ryan introduced a letter of commitment to the Pennsylvania Housing Finance Agency (PHFA) confirming \$16,000 has been committed to continue the Pennsylvania Housing Affordability and Rehabilitation Enhancement (PHARE) Rental Assistance Program for the period of January 1, 2022 to December 31, 2022 – Dept. 501.

**Action**: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to add the Letter of Commitment to PHFA to next week's Consent Agenda.

B. <u>Emergency Communications 911</u> – Assistant Director Rayme Weidel introduced a proposal from PBCI-Allen to install additional HVAC equipment in the 911 equipment room. The proposal total is \$11,435, which is eligible for PEMA Act 12 Funding for the period of July 27, 2021 to September 30, 2021 - Dept. 354.

**Action**: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to add the proposal from PBCI-Allen to next week's Consent Agenda.

C. <u>Correctional Facility</u> – Warden Schell introduced an intergovernmental housing agreement with Potter County. The contract rate is \$65 per day for the period of July 1, 2021 to December 31, 2023 – Dept. 333.

Action: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to add the agreement with Potter County to next week's Consent Agenda.

D. <u>Information Technology Systems</u> – Chief Information and Records Officer Chad Joyce introduced a quote from Qualtrics for data collection software to be used for grant applications. The Contract total is \$5,000 for the period of August 7, 2021 to August 6, 2022 – Dept. 142.

**Action**: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to add the Quote from Qualtrics to next week's Consent Agenda.

## A. <u>District Attorney</u>

Donna Schwenzer presented the following items:

- i. STOP Violence Against Women Grant application submission to the Pennsylvania Commission on Crime and Delinquency (PCCD). The grant total is \$435,000, which is funded as follows: Federal \$375,000, County \$30,000, and State College Police Department \$30,000 for the period of January 1, 2022 to December 31, 2024 Dept. 221.
- ii. Contract with Donna Schwenzer to perform the duties of Grant Coordinator for the STOP Violence Against Women grant through the Pennsylvania Commission on Crime and Delinquency. The contract total is \$14,700 which is Federally funded for the period of January 1, 2022 to December 31, 2024 Dept. 221
- iii. STOP Violence Against Women Pass-Through Agreement with Centre Safe to perform the project services outlined in the grant application to the Pennsylvania Commission on Crime and Delinquency for the STOP Violence Against Women Project. The contract total is \$147,300 which is Federally funded for the period of January 1, 2022 to December 31, 2024 Dept. 221.
- iv. STOP Violence Against Women Pass-Through Agreement with The Borough of State College to perform the project services outlined in the grant application to the Pennsylvania Commission on Crime and Delinquency for the STOP Violence Against Women Project. The contract total is \$113,850 which is Federally funded for the period of January 1, 2022 to December 31, 2024 Dept. 221.

**Action**: On a motion by Commissioner Higgins, seconded by Commissioner Dershem, the Board voted unanimously to add District Attorney items i-iv to next week's Consent Agenda.

Update on the 2019 Delinquent Upset Sale

Deputy Administrator John Franek reported that approximately 200 properties in Centre County have Delinquent 2019 Taxes. It is anticipated that 80 of these properties will proceed to the September Sale.

Approximately 400 properties in Centre County have Delinquent 2020 Taxes. The Board discussed the procedures in place to give property owners ample opportunity to pay these delinquent taxes. This includes Certified Notices, which will be mailed to the property owners on July 21, 2021. The County also contracts with Palmetto Posting to visit the owners and leave a physical posting on the property.
