

INSTRUCTIONS TO EXPUNGE A SUMMARY OFFENSE (Read Carefully)

Expungement is the removal of an offense from your criminal record. While information about the expunged offense will no longer appear on background checks, law enforcement and the Courts may still access this information to determine your eligibility for alternative punishment programs and grade future offenses.

The expungement process usually takes approximately 4-8 months to complete. If your petition is approved, a copy of the Expungement Order will be mailed to you at the address you listed on the petition.

To qualify, you must meet the following requirements:

1. You were convicted or pled guilty to the summary offense in Centre County.
2. You have not been arrested or prosecuted for any crime (including summary offenses) in any county in the five (5) years since being convicted of the offense you wish to expunge.

To request expungement of a summary offense, please complete the attached Petition for Expungement, the top section of the attached order, and obtain a recent certified copy of your complete criminal record from the Pennsylvania State Police (www.psp.state.pa.us)
(Your Petition may be rejected in not filled in completely)

****NOTE:** For Expungements from the Magisterial District Court a copy of the completed docket shall be included. These are accessible at (<http://ujportal.pacourts.us>)

*A copy must be served on the District Attorney and indicated on the Certificate of Service.
Failure to do so may delay the processing of your Petition for Expungement.*
