


## Final Certification

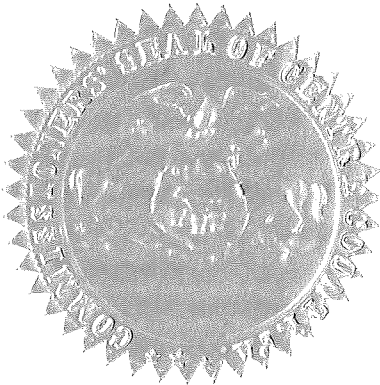

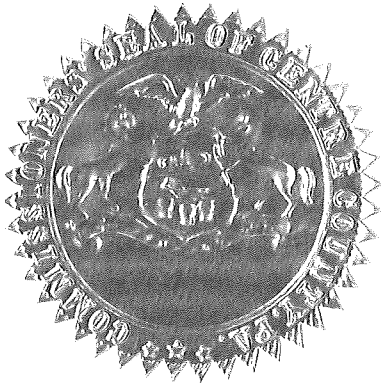
