ACTION ITEMS

David Burket Farm, 2021 PACE Applicant #1. Score: 77.367, 19.94 ranked acres

Narrative: David Burket's parcel is located at the intersection of West Pine Grove Road and Deibler Road in Ferguson Township (24-008-,008A). Though only 19.94 ranked acres, the farm meets the minimum criteria for the PACE program because the property is contiguous to the Larry, Sue and Dawn Harpster farm preserved in 2018 (24-008-,002). Allyson Ush, Chesapeake Bay Technician in the Centre County Conservation District Office, accompanied Centre County Agland Preservation Coordinator Diana Griffith on a stewardship site visit to the farm on June 28. They found the farm to be immaculately maintained and compliant with a conservation plan. They met Mr. Burket and were joined by the farm's operator Kirk Behrer, who is growing corn on the property. (Mr. Behrer owns and farms nearby parcel 24-008-,001.)

The Burket farm's soil values raw score is 90.126. More than 50 percent of the farm's soils are in Capability Classes 1 – IV.

Mr. Burket has an Agricultural Erosion and Sediment Control (AG E&S) Plan on file through Mr. Behrer, but the NRCS has no record of a conservation plan on file for this parcel. Dated April 2018, it was prepared by our Conservation District office's dedicated plan writer Tom Blair. Both Ally Ush of the Conservation District Office and Andrea Reiner of the PA Bureau of Farmland Preservation advised that the AG E&S plan is sufficient for compliance with their conservation plan requirements — if the County Board agrees that it is.

Mr. Behrer's AG E&S Plan for the parcel and Tax Parcel Map are attached.

Recommended Action: The Board will vote to accept Mr. Behrer's AG E&S Plan as the conservation plan for Mr. Burket's farm.

Recommended Action: The Board will vote to authorize an appraisal for the Burket farm, parcel number 24-008-,008A

Nancy and Webb Miller Farm, 2021 PACE Applicant #3. Score: 75.161, 62.33 ranked acres

Narrative:

Centre County Agland Preservation Coordinator Diana Griffith and Allyson Ush, Chesapeake Bay Technician in the Centre County Conservation District Office, paid a stewardship site visit to the farm on July 14. The 84-acre **Nancy and Webb Miller** farm is located on Harpswell Lane off South Nixon Road in Ferguson Township (24-004-,033A).

The conservation plan on file is that of preserved farm landowner Todd Irvin, the Millers' neighbor, who is their farm operator. Mr. Irvin is growing corn, soybeans, wheat, and snap beans on the Miller farm. Todd farms a number of our preserved properties in the area, including the nearby Ishler and Fleck farms. The Miller Farm is close to these and to Elwin Stewart's and Barbara Christ's Happy Valley Winery preserved farm next to the Foxpointe Subdivision.

The Millers' soil values raw score is 92.419. More than 50 percent of the farm's soils are in Capability Classes 1 – IV.

Mr. Irvin's Conservation Plan and the property's tax parcel map are attached.

Recommended Action: The Board will vote to authorize an appraisal for the Nancy and Webb Miller farm.
